The **Canadian Thoroughbred Horse Society (C.T.H.S.)** is a national organization, incorporated under the Animal Pedigree Act, representing breeders of Thoroughbred horses in Canada.

There are offices in Alberta, British Columbia, Manitoba, Ontario, and Saskatchewan.

Membership year is January 1 to December 31. Renewal Due Date: January 31.

The following three types of membership are available:

1. ANNUAL FULL MEMBERSHIP:

For persons, partnership or companies **who are owners of a Thoroughbred for the purpose of breeding Thoroughbreds in the current year** in Canada, whose application has been approved by the National Board and who have paid the prescribed membership fee. This type of membership entitles the member to:

- register foals at a preferred fee
- vote at C.T.H.S. meetings
- hold office
- give notice to Amend the By-laws
- participate fully in all activities and programs of the C.T.H.S. Division in which they reside.

Annual Full Membership Dues:

BEFORE January 31 - \$105.00 (includes \$5.00 GST/HST) for AB, BC, MB, QC & SK residents

\$113.00 (includes \$13.00 GST/HST) for ON & USA residents

\$114.00 (includes \$14.00 GST/HST) for PEI residents

AFTER January 31 - \$157.50 (includes \$7.50 GST/HST) for AB, BC, MB, QC & SK residents

\$169.50 (includes \$19.50 GST/HST) for ON & USA residents

\$171.00 (includes \$21.00 GST/HST) for PEI residents

2. FAMILY MEMBERSHIP:

For those persons who are the dependent children of an Annual Full Member not older than 24 years, or a spouse of an Annual Full Member, who resides with the Annual Full Member. The "Family Member(s)" will be able to register foals at the preferred Annual Full Member fee and will receive as a membership benefit, the \$25,000 Accidental Death and Dismemberment Insurance Policy. They will not have voting privileges or receive C.T.H.S. publications.

Family Membership Dues:

\$21.00 (includes \$1.00 GST/HST) for AB, BC, MB, QC & SK residents

\$22.60 (includes \$2.60 GST/HST) for ON & USA residents

3. ASSOCIATE MEMBERSHIP:

For persons, partnerships or companies whose application has been approved by the National Board and who have paid the prescribed fees. Associate Members CAN NOT register foals at the preferred fee, vote at meetings, hold office or give notice to amend the By-laws.

Associate membership Dues: \$52.50 (includes \$2.50 GST/HST) for AB, BC, MB, QC, & SK residents

\$56.50 (includes \$6.50 GST/HST) for ON & USA residents

ANNUAL FULL MEMBERSHIPS and ASSOCIATE MEMBERSHIPS include a subscription to the Canadian Thoroughbred Magazine, provincial publications and appropriate advertising as approved by the C.T.H.S. Divisions. Also, included as a membership benefit is a \$25,000 Accidental Death and Dismemberment Insurance Policy and reduced rates for many types of insurance for farms, horses, etc.
