PRIOR TO BREEDING MY QUALIFIED MAIDEN MARE, I HERBY MAKE APPLICATION TO THE CTHS BC DIVISION FOR APPROVAL TO THE MAIDEN MARE INCENTIVE PROGRAM 2018 AND I DECLARE AS FOLLOWS:		
<ol style="list-style-type: none"> 1. I am a BC Resident; 2. My mare qualifies and is either: Stake winning maiden mare, stake place maiden mare, maiden mare from stake type dam; maiden mare with stake typed siblings, or maiden mare that has earned a minimum of \$50,000 in her career. 3. I will breed the mare to a BC Sire and foal the mare in British Columbia; 4. I will sell the foal in a sale conducted by the CTHS (BC Division) or race the foal in British Columbia; 5. I understand that should I not sell the foal, that the foal's papers will be retained by the Race office at Hastings Racecourse until the end of the foal's two-year-old race season; 6. I understand I will receive \$1500 when my qualifying mare is confirmed in foal to a BC Sire by providing a vet certificate to the CTHS (BC Division); 7. I will receive \$500 when resultant BC bred is registered with The Jockey Club and the CTHS and the registration papers have been submitted to the CTHS (BC Division); 8. I will submit confirmation to the CTHS (BC Division) for both in-foal status and full registration prior to applicable payments being made to me; 9. I understand that repayment of any funds received under this program will release the papers; 10. That should I take advantage of the exception to the BC sire rule and breed my maiden mare outside BC prior to shipping my mare to BC, I understand that both foals must be registered as BC-bred and that both foals must be sold in the CTHS (BC Division) yearling and mixed sale or raced in British Columbia.
